There is also a Duty Holders area on the website – www.fia.uk.com – which gives links to guidance about arson prevention, false alarm management, and guidance specifically relating to Northern Ireland and Scotland as well as England and Wales.

There is a popular Best Practice Guide to Fire Safety for commercial premises. It is written specifically for the Duty Holder who knows little or nothing about fire safety issues and covers a range of topics including:

- Fire risk assessments
- Protective measures
- Fire fighting equipment and facilities
